## Detailed reports - monthly statistics of human rights violations – April, May and June 2015

### Statistics Section:

The following report is a result of efforts was recorded and reported by the Human Rights Commission of the National Council of Statistics survey in boarding the project to collect, analyze and document the reports filed by human rights defenders and related organizations. It is worth mentioning that because Iranian government do not allow the Human Rights organization and other groups to work freely, these reports are not complete reports, and only depicts a part of the systematic violation of human rights in Iran. Although this report has been prepared with great care but it is not error-free and error rate of 2% is considered in statistics.

Statistics executed in two months, April - May and June this year amounted to 251 individuals . Nevertheless number of executions since the eleventh government is headed by H. Hassan Rohani are 1659 people.

This report contains many sectors including women, children, prisoners , etc...and statistical study is descriptive.

In all categories a total number of 265 reports, registered, and analyzed that you will see the result of it as below:

Tehran Province, with 32% had the highest concentration of human rights watch, Kohgiluyeh and Booyer ahmad Province with a minimum of 0.1%, the lowest concentration of human rights defenders have been allocated.

440 Human Rights Violations in the field of thought and expression has been registered for 359 people.

751 cases in the field of human rights violations to 197 prisoners, have been recorded.

In Student categories 2 cases in the field of human rights violations for 1 student, have been recorded.

In execution categories 286 cases in the field of human rights violations for 270 individuals sentenced to death ,have been recorded.

In Children categories, 5 cases in the field of human rights violations to 3 individuals have been recorded.

1 case in the field of human rights violations to women have been registered for 1 individual.

In the cultural categories 7 cases in the field of human rights violation to 5 individuals have been recorded.

In the Guilds categories 1511 cases in the field of human rights violation to 1507 individuals have been recorded.

80012 Human Rights Violations in the field of ethnic minorities have been registered for a 80011 individuals.

42 Human Rights Violations in the field of religious minorities have been registered for 23 individuals.

5317 human rights violations in the field of workers' rights have been recorded for 2618 individuals.

0 human rights violation in the field of environment and health care has been recorded.

In other human rights violations , 178 cases for 178 individuals have been registered.

**The name of the detainees in (April - May and June 2015) are as follow:**

In these two months security and police forces arrested 48 individuals. With these actions the right to freedom of opinion and expression, the right to liberty and security of person have been violated. Article 19 of the Universal Declaration of human rights, explicitly states that , anyone has the right to freedom of opinion and expression. Also in paragraph 1 article 9 International Covenant on civil and political rights States: Everyone has the right to freedom and security of a person , no one shall be arbitrarily arrested or detained;. In the foregoing paragraph to article 19 States: No one shall be harassed or scared because of his ideologies. Paragraph 2 of article 19 add: everyone has the right to freedom of expression; This right includes the freedom of study and inquiry and Impart information and ideas of any kinds, regardless of frontiers, either orally, in writing or in print, in the form of art, or through any other media of his choice.

#### **Statistical Report ( 21 April –29 June 2015):**

Detailed reports leading human rights as described in the (April-May and June 2015 ) puts at your disposal; that by the Human Rights Commission of the National Council of Iran , according to numerous reports of human rights organizations has been collected. It is worth mentioning due to lack of proper watch on all parts of the country this report may not be complete.

#### **Freedom of opinion and Expression:**

Tuesday April 21<sup>st</sup> , Doctor heidarpour former prison doctor who hadn't want to lie about the death of blogger Sattar Beheshti's report was summoned to the Branch 28 of the Revolutionary Court, presided by Judge Moghiseh .

Wednesday April 22<sup>nd</sup> , Kassem Exsir Fard , a prominent professor of physics who has sit out in front of Khajeh Nasiradin university to protest against the disqualification of having Female Voice were beaten by university security guards.

Wednesday April 22<sup>nd</sup> , Mohammad Reza AaliPayam, Satirist poet accused of blasphemy of Quran and Imam –Zaman , Ayatollah Khomeini and Iran Leadership , propaganda against the regime and insulting the president has sentenced to 15 months in the prison he has introduced himself to prison and was moved to 8th ward of the prison.

Thursday April 23<sup>rd</sup>, Annalistic news site called Ensaf News was filtered Nobody knows of why and how the site is blocked or by which Organization.

Thursday April 23<sup>rd</sup>, News site called Bahar News Following a cyber attack on the server was out of reach.

Saturday April 25<sup>th</sup> , Conference Seminar at Isfahan University about achievements of nuclear negotiations with speech of Mr.Hermidas Bavand and Mr. Ziba kalam by oppression of the extremists inside and outside the university , was canceled by the Supervisory Board .

Tuesday April 28<sup>th</sup>, Hosein Noorani Nejad, a member of participation party and Who is close to Mohammad Khatami, first was sentenced to 6 years in prison by Judge Salvati, his condemnation reduced on appeal to one year and returned to Evin prison for serving.

Sunday April 26<sup>th</sup> , Baktash Abtin, A Poet, filmmaker and member of the Writers' Association of teachers in activities in the center was being interrogated by security officers of The Ministry intelligence.

Monday April 27<sup>th</sup>, A news paper named Zana-e- Emrooz ( Today's Women ) to promote and explain a phenomenon called White marriage in the meeting of the Supervisory Board of press was banned and the case was referred to court.

Tuesday April 28<sup>th</sup>, Narges Mohammadi Vice President of the Center for Defense of Human Rights , to deal with the new case on May 3<sup>rd</sup> was summoned to the branch 15 of the Islamic Revolution court presided by Judge Salvati .

Wednesday April 29<sup>th</sup> ,simultaneous by Rohani journey to Shiraz , Mehdi Sadat, Farkhondeh Kargar, Mohammad Javad Keshavarzi, and Omid Masoudi , staff members of the reformist young people welcomed the President before the speech, of Hassan Rohani, were arrested by security agents and nobody is aware of the organization in charge or what is the reason of this arresting.

Wednesday April 29<sup>th</sup> , Security forces raided the house of Reza Khandan a resident of Mahabad city , author , literary critic and member of the Iranian Writers' Association teachers , They seized Manuscripts and his archives his cell phones and his computer hard drives and handed him the summons ,On Sunday, May 3rd on charge of propaganda against the regime must go to the Court of the media and culture Branch 12 for questioning .

Monday May 4<sup>th</sup>, Two people on charges of publishing false news in cyberspace were arrested by security forces and the case was sent to court.

Monday May 4<sup>th</sup>, Neda Mostaghimi , one of protectors of Mothers of Laleh Park, , was arrested at her workplace by security forces, To serve three years in prison, it is unclear what prison was transferred to serve .

Monday May 4<sup>th</sup>, The editor of Mardom-e Emrooz news paper was charged with publishing a picture of blasphemy .The court was held in Branch 76 of Tehran Penal Court.

Tuesday May 5<sup>th</sup> , Security forces with a judiciary warrant , has arrested human rights activist, Narges Mohammadi, at her home and was taken to Evin prison. The reasons for the detention and new charges is unknown.

Monday May 4<sup>th</sup>, On the verge of trial of Arash Sadeghi and Golrokh Ayrayy on 6 May in Branch 15 of the Revolutionary Court presided by Judge Salvati has been refused to provide documents to their lawyers to study the case and be able to defense.

Thursday May 6<sup>th</sup> , Security forces by a phone call have threatened and arrested the members of the National Front to prevent the meeting of the central committee were organized.

Thursday May 19<sup>th</sup> , Mohammad Reza Moradi The editor of Bayan Eghtessad Leaflet in Islam Shahr city in its last issue has mentioned about corruption of Vali Allah Asghari Deputy Chiefs Friday Prayer and the head of Islam shar with request of Mohammad Ali Nourozi The Friday prayer's Imam of Islam Shahr with a complaint to public prosecutor was arrested .

Saturday May 23<sup>th</sup> , Keyvan Bajan , Writer and member of the Iranian Writers' Association , was summoned by telephone to intelligence office for questioning .

Wednesday June 3<sup>rd</sup> , Koroush Zaeim, Member of the National Front has summoned for the several times on charges of acting against national security, propaganda against the regime and membership in the National Front on July 4<sup>th</sup> of this year , was summoned to Branch 15 of the Revolutionary Court , presided by Judge Salvat.

Thursday June 4<sup>th</sup> , Zakaria Ghaderi Professor of political science at the Azad University of Kermanshah for Science and Research because of discussions considered in his classes and published articles in the press by his name , was banned from teaching by university's security .

Saturday June 6<sup>th</sup> , Ahmad Sattari director of Mardom e-emrooz News paper has charged by paying 2 million Tomans fine and Mohammad Ghouchani the editor of the newspaper was acquitted today after publishing an article as" I am Charles" and the news paper office was banned by Court order in the second branch of culture and the media court.

Sunday May 31<sup>st</sup> , Hamed Ghanbari, mahmoud Mousavi, Shayan Akbarpour, and Amir Ben saeed who are social networking activists were arrested by the security forces in Tehran.

Monday June 1<sup>st</sup> , Ehsan Allah Amoozgar and Arash Hallaj ,Music underground activists were arrested and beaten by security officers .

Sunday June 14<sup>th</sup> , Minoos Mortazi Langeroodi Member of the national-religious activist and women's rights activist charged with gathering and for launching the national-religious activist to five years And

one year for propaganda and black washing against regime was sentenced in the Revolutionary Court Branch 15 by Judge Salvati.

Sunday June 14<sup>th</sup> , Director of hamshahri News paper charged of spreading lies to harm other and with a private complaint was convicted in Branch 79 of Tehran Penal Court presided by judge Mohammadi kashkooli , in front of the jury of press.

Sunday June 14<sup>th</sup> , Director of Iran News paper On charges of defamation through the insertion and release of a judicial investigation and the publication of lies was convicted in Branch 79 of the penal Court presided by judge Mohammadi kashkooli , in front of the jury of press.

Sunday June 14<sup>th</sup> , Manager of 'Cinema Press' Site on charge of spreading lies with the intention to harm the other presented in Branch 79 of the penal Court presided by judge Mohammadi kashkooli , but was not convicted by the jury of press But for not abiding the mission of press has received a warn.

Thursday June 11<sup>th</sup> , Teimour Khaledian Who hold placards in protest against censorship on radio and television was holding a sit- in in front of the department charged with public order offenses , was arrested by unusual way And contrary to the principle of separation of offenses is maintained in Section 10 of rajaee Shahr Prison.

Monday June 15<sup>th</sup> , Soolmaz Eikdar a Journalist ,Social activist and defender of children and women rights , was arrested. she was among the 101 journalists who protested against threatening and exiling of Ahmad Zeid -Abadi the journalist and signed a statement.

Thursday June 18<sup>th</sup> , Ahmad Reza Ahmadpour the exiled cleric was summoned again to the special court of Qom and the cause of the summon is not known .

Saturday June 20<sup>th</sup> , The five-member group working on labor articles in ILNA News were fired .

Saturday June 20<sup>th</sup> , Zeinalabedin Ghaemi Khorasani blogger charged with propaganda against the regime and insulting the leadership and encouragement of public opinion was sentenced to 3 years imprisonment .

#### **Prisoners Status:**

Wednesday April 22<sup>nd</sup> , 9 person sentenced to death for drug charges and one person to be executed for murder in Bandar Abbas Prison were transferred to solitary confinement.

Tuesday April 21<sup>st</sup> , Khosrow Mansoorian , Political prisoner in Evin prison, was taken to hospital due to heart problems .

Tuesday April 21<sup>st</sup> , Rasool Bodaghi Teacher and political prisoners in Rajai Shahr ward 12 was summoned to Branch 6 Judicial Moghadas Complex in Evin prison for interrogation.

Wednesday April 22<sup>nd</sup> , Minab prosecutor's has objected the request of sick leave for Mohammad Hossein Rezai a Kurdish political prisoners who is in poor health.

Thursday April 23<sup>rd</sup>, Saeed heidarpour who has returned to Iran in 2014 and was charged with propaganda against the regime, publishing lies and insulting the Supreme Leader in cyberspace was arrested ,after interrogation and arraignment was moved to Section 8 of Evin Prison , then was taken to address the allegation in Rajae Shaher prison .

Thursday April 23<sup>rd</sup>, Mohammad Hoseinzadeh a civil right activist who in 2014 was arrested for acting against national security through propaganda and illegal gathering was taken to prison of Sepah ward 2 , has convicted in branch 28 of the Revolutionary Court , presided by Judge Moghiseh to seven years in prison and he is now in Section 8 of Evin prison.

Friday April 24<sup>th</sup> , Ramazan Ahmed Kamal the Syrian nationals on charges of membership in the Kurdistan Workers' Party in Turkey was sentenced to ten years in prison because of neglecting his medical problems and damage caused by gunshot at the time of arrest he is not in good physical condition he was summoned from Rajai Shahr prison to court .

Friday April 24<sup>th</sup> , Mohammad Khatibi an artist and filmmaker in December 2013 was returning to Iran had been arrested in Imam Khomeini International Airport to some of the comments , To serve a prison sentence was transferred to Evin prison and the extent of his imprisonment not known.

Saturday April 25<sup>th</sup> , majid Moghadam a political prisoner in section 8 of Evin prison who was protest of being there and abusive behavior by prison authorities kept in bad health condition and was beaten by thugs he has started the hunger strike again.

Saturday April 25<sup>th</sup> , Behnam Ibrahimzadeh a labor activist who was in ward 209 of Evin prison and was transferred to the central clinic in that prison , this time they have taken him to Rajai Shahr prison ward 2 .this prisoner suffer from Arthritis of the neck.

Saturday April 25<sup>th</sup> , Ali Shariati a political prisoner who was arrested by intelligence and security officers of Hassan Rohani and transferred to section 209 of Evin prison , held 3 months in detention pending.

Sunday April 26<sup>th</sup> , Majid Jafaritarabar a clergymen are known in Qom with his wife and three others on charges of apostasy, adultery , sodomy and the magic genie were sentenced to death by stoning.

Sunday April 26<sup>th</sup> , Mohammad Reza Aalipayam poet, comedian critical of the government was transferred to the quarantine part of Rajai Shahr Prison . He was denied contact with the outside Throughout his detention.

Tuesday April 28<sup>th</sup> , Masoud Bastani Journalist prisoner who suffered from a heart attack and severe weakness of his left side nerves was transferred to Rasoul Akram Hospital and remained in bad physical shape.

Monday April 27<sup>th</sup> , Ghadrieh Qaderi a Kurd political prisoner in Yasooj prison to protest keeping her among ordinary criminal prisoners and denial of her leave of six days , she is now in hunger strike , and her physically conditions is inappropriate.

Monday April 27<sup>th</sup> , one of the officials of the Special Court for the Clergys to name Nosratabadi , after hours of interrogation of Mr. Ayatollah Boroujerdi has informed him for publishing of his new book should prepare himself for new trial.



Sunday April 26<sup>th</sup> , Rasool Bodaghi the teacher prisoner , on the pretext of transfer to Evin prison was transferred to an unknown location.

Tuesday April 28<sup>th</sup> , Molavi Abdolqafar Naqshbandi , Malek Mohammad Abadian, and his sons by intelligence agents of the central prison of Zahedan were transferred to the Ministry of intelligence and the cause of transmission is unknown.

Tuesday April 28<sup>th</sup> , with verbal command of deputy prosecutor and prosecutor overseeing the security of political prisoners detained in the hospital, daravishes prisoners were required to use the handcuffs and shackles. Hamidreza Moradi and mostafa Daneshjoo two of Daravish Gonabadi's rights activists who were in Tajrish Hospital for treatment, have refused obeying this rules , so prison's officials threatened them to stop the process of treatment and returning them to prison.

Wednesday April 29<sup>th</sup> , in the second floor of Adel Abad prison in Shiraz the clashes between prisoners and the guards raised up . Riot police entered the prison started to beat the prisoners , the causes of conflict and the toll is unknown.

Wednesday April 29<sup>th</sup> , Hosein Ronaghi a political prisoner who was transferred to section 7 in Evin prison , in spite of kidney problems , they stopped his treatment .

Friday May 1<sup>st</sup> , the political prisoner Hosein Nooraninejad,who was summoned to Evin prison transferred to section 8.

Sunday May 3<sup>rd</sup> , a Christian pastor Behnam Irani who has called to express remorse and regret but he rejected. So The Public Court of karaj , refused his conditional release.

Saturday May 2<sup>nd</sup> , Farooq Samani a political prisoner who was convicted of propaganda against the regime and acting against national security by gathering . Held in Mahabad prison for three years, he hasn't received any holidays.

Tuesday May 5<sup>th</sup> , Seven accused of drug trafficking were transferred for execution to solitary confinement in Adel Abad Prison in Shiraz.

Monday May 4<sup>th</sup> , Ali Moezi from 70s political prisoners, After he refused of sending him to the court he was beaten by 5 officer and a major and his forehead was injured. And then took him to branch 1 of Karaj Court presided by Judge Asif Husseini .They forced him to sign the sentence of one year in prison. He is now in the central prison of karaj.

Wednesday May 6<sup>th</sup> , Reza Entesari a rights activist of Gonabadi Daravishes ,Evin prisoner who refused to wear the prison clothes and the use of handcuffs and shackles were prevented from sending him to the hospital.

Tuesday May 5<sup>th</sup> , Saeed matinpour a Journalist prisoner for reasons unknown, was transferred from the central prison of zanzan to quarantine part of Evin prison and then to ward seven.

Wednesday May 13<sup>th</sup> , Mohammad Mozafari a member of students and graduates of the National Front after 88 days of detention in Unit 2of Sepah prison was transferred to unit 6 of general ward of Evin and he has contacted with his family by phone .

Tuesday May 12<sup>th</sup> , Atena Daemi the civil right activist was sentenced to seven years in prison on charges of propaganda against the regime and acting against national security by gathering and Blasphemy and insulting leadership and concealing her crime evidences.

Sunday May 10<sup>th</sup> , a political prisoner mansoor Arvand ,for unknown reason has been transferred from Mahabad prison to an unknown place.

Friday May 8<sup>th</sup> , A person charged with dealing drugs in Nahavand city sentenced by 74 lashes in public, also was sentenced to three years and half in prison.

Sunday May 17<sup>th</sup> , Ali Shariati a political prisoner from Green Movement, who undecided be kept in prison for refusing to shave his head was beaten. He declared a hunger strike to protest the continued detention which is not legal.

Tuesday May 19<sup>th</sup> , The trial of Athena Frqdany artist and social activist held in Branch 15 of the Revolutionary Court, presided by Judge Salvati.

Monday May 18<sup>th</sup> , Abdolvahed Gomsh Dezhi from Saravn in Sistan Baluchistan because of Hematoma in his head and due to lack of medical facilities in Zahedan prison has died.

Tuesday May 19<sup>th</sup> , Negar haeri who was interrogated in Evin Court on May 18<sup>th</sup> , had been transferred to Ward 209 of women part in Evin prison .

Wednesday May 20<sup>th</sup> , Mansoor Arvan a political prisoner who was sentenced to life imprisonment. He has transferred by intelligence officers of Mahabad Central Prison to an undisclosed location, after that they transferred him to Miyandoab prison.

Wednesday May 20<sup>th</sup> , Ibrahim Maddadi and Davood Razavi from Vahed union leaders were arrested in tuesday 28 April by agents , transferred to Ward 209 of Evin Prison and to quarantine part of the prison . They were able to contact their families .

Thursday May 21<sup>st</sup> , Ahmad Zeinabadi the journalist and political prisoner Immediately after his release from Rajai Shahr Prison has exiled to the city of Gonabad .

Thursday May 21<sup>st</sup> , a political activist after 43 days of his detention , despite the end of his interrogation in detention continues to be extended.

Saturday May 23<sup>rd</sup> , Ehsan Shahqasemi who beat and stabbed a Basiji member named Ali Khalili, while doing the good and forbidding advice in 2011. Khalili who gave him his satisfaction after taking his blood money , but after all Khalii has died in hospital in 2013 because of shortage in his treatment in hospital . For that reason Once again the case has opened and Ehsan Shah Qasmi has sentenced to death on charge of murder and has confirmed by the Supreme Court of Iran's judiciary.

Saturday May 23<sup>rd</sup> , Six charged with drug offenses in prison Ghezelhesar in Karaj for execution were transferred to solitary confinement.

Saturday May 23<sup>rd</sup> , Asadollah Assadi a political prisoner from Azerbaijan In section 7 of Evin Prison has faced a stomach bleeding , but prison officials have refused to transfer him out of the prison hospital.

Monday May 25<sup>th</sup>, Abolqasem Fooladvand a political prisoner in Rajai Shahr prison he has transferred to a hospital for doing a surgery , In protest against the handcuffs and shackles and restraint of his family visit, began a hunger strike and therefore no complete cure was returned to prison.

Thursday May 28<sup>th</sup> , Heiman Ghazali and Abdolrahman Ramazanpour, two political prisoners in Mahabad prison In protest against the non-compliance with the prison guards were suspended two weeks of the vesting.

Thursday May 28<sup>th</sup> , Mohammad Seifzadeh the political prisoner and Lawyer due to bad conditions in political section of ward 12 in Rajai Shahr Prison , he is having severe difficulty in breathing.

Monday June 1<sup>st</sup> , Atena Farqdani a children 's rights activist and painter jailed in Evin prison on charges of assembly and collusion against national security, propaganda against the regime with intent to insult the president and insult to Parliament and insult to officers of Evin prison during interrogation . She was sentenced to 12 years and 9 months in prison in branch 15 of the Revolutionary Court presided by Judge Salvati.

Monday June 1<sup>st</sup> , Omid Alishenas a civil right activist on charges of acting against national security and propaganda against the regime and conspiracy to insulting the leadership was sentenced to 10 years in prison.

He suffer from health problems such as lung infections , bone pain and tissue breakdown disease despite of over two and a half of his imprisonment he has not received a sick leave yet.

Saturday May 30<sup>th</sup> , Khalid Hardani a political prisoner in Rajai Shahr prison because of severe abdomen and fever was transferred to the clinic .

Sunday May 31<sup>st</sup> , Behnam Ibrahimzadeh labor activist and political prisoner in Rajai Shahr prison after an argument with the Head of Section ( Najm al-Din Hosseini ) as a result of the news spread to media , has beaten by the head of section . Sunday May 17<sup>th</sup> , The young movie director Saleh Deldam announced that will do a dry hunger strike in the courtyard of the Ministry of Culture because of no licensing the release of his new movie.

Tuesday May 19<sup>th</sup> , Hojat-islam Ghobishavi the Friday prayer's Imam of Mahshahr port in Khozestan and a group of people gathered on the scene of concert for Mehdi Ahmadvan the singer and banned the show.

Wednesday June 10<sup>th</sup> , The concert of parvaz-e- Homai which supposed to perform after eight years delay on the stage of Interior Ministry , was canceled by order of the judicial authority .

Tuesday June 9<sup>th</sup> , The singer Keyhan Kalhor who was going to go on stage in Iran for performance after a long time, because of no licensing by security Office the show has canceled.

Thursday June 11<sup>th</sup> , The concert of Payvar Band has been canceled in Rasht city.

Tuesday May 12<sup>th</sup> , Movlana Gergij the Sunni Friday prayer leader in Azad Shar city of Zahedan once again was banned to participate in the yearly conference in National Darul ulom of Zahedan by the Ministry of Intelligence's order .

Monday May 18<sup>th</sup> , Farhad Salimi a Sunni Kurdish prisoners detained in Rajai Shahr prison in Tehran's was called by Revolutionary Court Branch 28 , presiding by Judge Moghiseh.

Tuesday May 19<sup>th</sup> , Ebrahim Gholami Student of Industrial Engineering, Mostafa Khodeir the Labor and a Sunni citizen from Mahabad have been detained and their whereabouts are not known , but the charges .

Sunday May 24<sup>th</sup> , In Sari City ,three Baha'is places , Hadi Ziaollah Khoshbin (paint shop ) , Kamal Akbari ( woodturning), Ehsanollah Sanai ( Cosmetics ) due to the closure date except for holidays, were sealed .

Sunday June 7<sup>th</sup> , Abbas Salehian one of the Sufis in Golpaiegan city was taken to branch 101 of the Criminal Court on charges of committing a forbidden act by promoting the ideas of the Gonabad Sufis. Order was issued to 74 lashes while he had not access to a lawyer.

Wednesday June 10<sup>th</sup> , masoumeh Ziae one of Erfan Halghe activists in the gathering of supporters in front of the Revolutionary Court in 2014 had been arrested on charges of disturbing public order by participating in illegal gatherings , by Branch 54 of the Tehran Appeals Court was sentenced to one year imprisonment and 74 lashes .

Wednesday June 10<sup>th</sup> , Hamid Azizi, a baha'i citizen in Hamadan, on charge of the propaganda on behalf of groups opposed to the system he has to tolerate one year imprisonment . so he introduced himself to Hamedan prison.

Friday June 19<sup>th</sup> , In Sharyar city The municipality and the police 's officers had order to demolish a nursing home which is under construction belong to Sufi's dervishes. The group who resisted them were beaten and broke the windows of the building.

Saturday June 13<sup>th</sup> , Sasan Haghiri a Baha'i citizen , who was charged on May 2014 of assembly and collusion against national security, propaganda against the regime , by Yazd Court to one year imprisonment and one year suspended sentence . So for one year imprisonment was to get introduced to the central prison of Isfahan.

Saturday June 20<sup>th</sup> , Kazem Dehgan from Gonabadi Sufis with six other persons who were exiled to Zabol city on charge of war on God. With complaints of Kavar city police chief charged them with publishing lies for disturbing public opinion, They have taken to criminal court presided by Judge Jafarzadeh.

Wednesday April 22<sup>nd</sup> , Vrdsen machine brick factory in Nasirabad Golestan province, which a year ago, on sales of products has faced troubles in the payment of workers .On the orders of the employer has shut down for 5 months .The works unemployed with unpaid wages.

Friday April 24<sup>th</sup> , A number of projects worker of phases 17 and 18 in Assaluyeh suffered poisoning from breathing hydrogen sulfide gas that two of them were killed.

Thursday April 30<sup>th</sup> , Sheis Aman a labor activist and Board member of the Free Union of Iranian Workers in Sanandaj summoned to the Intelligence Ministry and was interrogated for more than 5 hours. Security forces were trying to avoid having to celebrate 1<sup>st</sup> of May .

Friday May 1<sup>st</sup> , After the 8 -year hiatus in celebration of Labor Day on 1<sup>st</sup> May, 10 thousands of workers gathered at Palestine Square.

Friday May 1<sup>st</sup> , Mahmoud Movlai one of the five injured in Imam Khomeiny refinery blast in Shazand , died in hospital.

Wednesday April 29<sup>th</sup> , Shaheen Ahmadi Begjan a worker of Asal Ice cream factory in industrial area of sanandaj, who her hand first was dragged into the product line and then her body was dragged into the machine died.

Tuesday May 5<sup>th</sup> , Alireza Dehghani One of the injured workers in the accident of Shazand refinery died.

Wednesday May 6<sup>th</sup> , Hassan Ibrahim One of the injured workers in the accident of Shazand refinery died.

Wednesday May 6<sup>th</sup> , Following the collapse of the old well in Tehran a 15 -year-old worker who was in well to save another worker who was trapped in the well , after saving the worker the old worker has held in the well and after saving him by firefighters died.

Thursday May 7<sup>th</sup> , Ahwaz Urban Railway Project workers protest against the lack of provincial authorities the situation of the workers entered the eleventh day.

Thursday May 7<sup>th</sup> , 1000 workers of Safa Rolling and Pipe factory to protest the delay of 4 months wages have ceased a week at work.

Tuesday April 28<sup>th</sup> , Ibrahim Madadi and Davood Razavi Two union leaders were arrested by a warrant from the Amin Nasser the interrogator of 6 branch of Evin Court Were arrested by agents of intelligence services the charges and detention are not known.

Sunday May 10<sup>th</sup> , Mehdi Salarvand who during Shazand refinery overhaul was severely poisoned and died.

Tuesday May 12<sup>th</sup> , Three pipe workers in Ahvaz , Khuzestan had been summoned to the Qouds Judicial Complex, A group of workers in this field to protest against the behavior of abusive of employers have gathered in front of Ahvaz governor department for two days.

Sunday April 26, Khalid Hoseini a labor activist and a member of the Coordinating Committee to Help Form Workers' Organizations was summoned by a phone call to the intelligence office of Sanandaj city .and was interrogated for 2 hours in front of Coordination Committee of the first of May the Labor Day.

Tuesday April 28<sup>th</sup> , Along with dozens of teachers retired , workers gathered in front of parliament, demanding the release of imprisoned workers and teachers.

Tuesday April 28<sup>th</sup> , A factory worker of Nykpoo factory in Eshtehard Industrial area for not observing the safety principles died under the press machine.

Saturday April 25<sup>th</sup> , Reza Amjadi a labor activist and a member of the Coordinating Committee to Help Form Workers' Organizations in sanandaj was arrested by security officers and has taken to an unknown place.

Tuesday April 28<sup>th</sup> , Mahmoud Salehi from labor activists was arrested in saqez city.

Tuesday April 28<sup>th</sup> , Othman Salehi from Mahabad city a member of committee for the Defense of labor activists was arrested in Mahabad .

Wednesday April 29<sup>th</sup> , Pedram Naser Abdolahi a labor activist and a member of the Coordinating Committee to Help Form Workers' Organizations in sanandaj , following the attack of security agents on the home of his friend was arrested and taken to an unknown location.

Wednesday April 29<sup>th</sup> , Jafar Azimzadeh Labor activist and secretary of the board of the Free Union of Iranian Workers in charge of gathering and colluding with the aim of acting against national security and disturbing public opinion and propaganda against the regime 's in the revolutionary Court Branch 15 presided by Judge Salvati was sentenced to six years, following the gathering in May 2015, during a phone call from the office of the Ministry of Intelligence was summoned to Tehran , but no information is available on the release or his detention.

Friday May 15<sup>th</sup> , Two Afghan construction workers while digging a well in Tehran Khazaneh area , lost their lives.

Saturday May 16<sup>th</sup> , Khuzestan Pipe workers in protest of not receiving wages of 10 months for the third time have gathered in front of the governor department in Ahvaz.

Tuesday May 19<sup>th</sup> , Davood Sahli One of the three workers who last week was burned by the eruption of lava in the boiler shop of Khorasan Steel factory, died due to injuries the two other workers Hojat Sharqi and Akbari held in CCU in Imam Reza Hospital.

Thursday May 21<sup>st</sup> , Following the crash of a crane in the coal mines in Damghan in May 19<sup>th</sup> , a worker was injured in Damghan died after three days in the hospital.

Thursday May 21<sup>st</sup> , Reza Amjadi a labor activist and a member of the Coordinating Committee to Help Form Workers' Organizations , by the Sanandaj Revolutionary Court was convicted to three months and one day in prison.

Saturday May 23<sup>rd</sup> , In the thirty- second day of strikes in Safa factory pipes and rolled in Saveh in protest at delay of salaries four months and over 16 months of premium rights ,10 person of protesters were dismissed.

Monday May 25<sup>th</sup> , Jafar Azimzadeh Jafar Azimzadeh Labor activist and secretary of the board of the Free Union of Iranian Workers on charges of inciting workers who were in strike over a month in Safa pipes and rolled factory , ordered by a judge to the Court of Saveh Branch 1 was sent to the detention center.

Monday May 25<sup>th</sup> , Shapoor Ehsanirad To advise and represent workers in Safa Factory of pipe and rolling on for stimulating workers was arrested and put on trial.

Monday May 25<sup>th</sup> , Mohammad Salehi a labor activist and a member of the Coordinating Committee to Help Form Workers' Organizations Who was arrested in May of this year, the detention was extended until the end of June.

Tuesday June 2<sup>nd</sup> , An excavator driver and an engineer named Ahmadi and Farzannia by landslides caused by the explosion were killed and another worker was injured in the project of Mashempa dam in Zanjan.

Sunday June 7<sup>th</sup> , Sixty workers of Green complex of Mahabad to protest for delayed 11 months of salary for the fourth time in the last week in front of the Green complex.

Sunday June 7<sup>th</sup> , 200 workers of Tabriz powerhouse to protest the privatization of the powerhouse and arrears 9 months of benefits in the area of East Azarbaijan Power Management gathered.

Thursday June 4<sup>th</sup> , a worker of the Persian Gulf Star refinery employed in construction projects due to the collapse of a large pipe pieces on Jack was killed.

Wednesday June 10<sup>th</sup> , Two Afghan workers were busy digging the well in the courtyard of Industrial companies due to a lack of safety in the well kept and lost their lives by gas.

Wednesday June 10<sup>th</sup> , 90 workers from Alborz Steel Factory in Takestan in Qazvin Which have not been paid for three months and a year ago, so far 210 of the 400 workers were fired after working there.

Tuesday June 9<sup>th</sup> , 120 workers of Iran Barak factory In the twenty- second day of protests in reaction to the disregard of the employer to pay demands and protesting the way of selling the building.

Thursday June 11<sup>th</sup> , 2 Afghan workers have fallen from the height of a building under construction which collapsed in Dezful. One person was killed and others were injured.

Thursday June 11<sup>th</sup> , 900 foundry workers of Sahand industry in Zanjan still have not received salaries from March of last year.

Tuesday June 16<sup>th</sup> , One of the dismissed workers of mining company named Madanjoo to protest the suspension of the mine were gathered at the beginning of the Pabdana road in an accident with a trailer carrying a load was killed.

Thursday June 18<sup>th</sup> , 120 workers of Iran Barak factory In the thirtieth day strike wrote to the Director-General of Gilan province and called their demands the timely payment of monthly salaries that were delayed for 9 months.

Wednesday June 17<sup>th</sup> , A worker on scaffolding installed on the second floor of a hospital under construction as a result of the lack of safety at work with electric shock and lost his live in Fakoori Boulevard in Tehran.

Saturday June 20<sup>th</sup> , Two construction workers due to falling from the fifth floor of the building under construction in the area Golshahr lost their lives.

Saturday May 9<sup>th</sup> , 12 individuals from the protesters in a ceremony organized for losing Farinaz Khosravani , in Sardasht were arrested by the security guards.
